

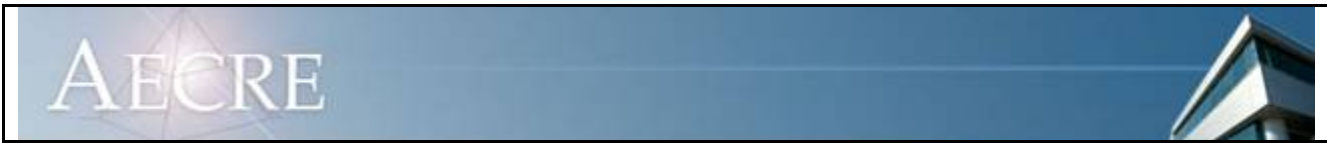
Dear AECRE Members:
